1. Introduction

Friends we have passed yet another eventful year at Adarsh. Unlike previous years this year was really eventful with lot of positives to starts with. The year culminated with the challenge of COVID19. Ever since it started we have been facing the situation in the best way possible. Many corporates and individual and all of our Trustees are strongly with us during this most difficult period. We are grateful to all of them for their support. As your founder secretary it gives immense pleasure for me to welcome all for this 22nd Annual General Body meeting. I am thankful to all our Trustees for bestowing the confidence in me that too continuously for twenty-two long years. I am grateful to all of you.

Friends, with utmost sorrow I report the demise of two of our Trustees and close associates

Shri. P.S. Raman, who was our newly elected GC member always supported us whenever we requested for the same. As a philanthropist he was involved in various cultural and social activities in and around Kochi. We lost a great friend of Adarsh by his demise.

Shri. C.K. Menon was a support for Adarsh especially in our most difficult period. His huge contribution made during the construction of our main building was the most appropriate and timely help to our organization. We are sure that without that gesture we could not have finished our Main Building within the schedule time. Shri. C.K. Menon and his family used to visit Adarsh whenever they found time. His whole family was very close to our heart and close to the children of Adarsh. With his demise we lost a strong supporter of Adarsh. He was our Chief Patron.

We also report the demise of Kum Priya Pradeep, a student from Multiple Disability unit, Shri Ranji Mathew (Father of Mathew Ranji from Autism Unit), Shri Rajesh Unni (Father of Rahul Unni from Autism Unit) and Smt Akkamma (Grandmother of Minu Manilal from Sr. Secondary class) during the reporting period. ACT deeply mourns the demise of the above people and we all pray for their soul may rest in peace.

We the members of Adarsh family deeply mourn the sudden demises of two of our Trustees.

With these few words let's turn our attention to the main activities of our Trust which is explained for you in the following pages.

2. Adarsh Charitable Trust

'Adarsh', a non-profit charitable Trust, registered under the Registration Act, 1908, was established in 1998 with an objective to Rehabilitate Persons with Mental and Physical challenges. Since then the Trust has been providing rehabilitation services to children affected by Cerebral Palsy, later extended to those affected by other challenges like Autism, Down syndrome and Learning Disorders also.

b. The Trust has its registered office at XIV/547 B& C, Opp. Agasthya Ashram, Kureekkad P. O., Ernakulam. It is in Chottanikkara Panchayat (13 Kms from Ernakulam Town) of Ernakulam District in Kerala State. It owns a land of 40 cents and a disabled friendly building of around 20000 sq.ft., for the rehabilitation of children with challenges. The Child Development Evaluation Intervention and Research Centre functions at Vyttila, Ernakulam in a rented building since 2007.

3. OBJECTIVES, VISION, MISSION and MOTTO.

a. Objectives

- i. For helping physically handicapped and mentally challenged persons;
- ii. To rehabilitate persons with Cerebral Palsy and persons with other disabilities;
- iii. To give medical assistance and relief to those who are poor and have become mentally and physically challenged through accidents or other calamities;
- iv. To establish and/or construct, run and aid institutions, medical relief centres for this purpose;

- v. To promote research in the field for Community Based Rehabilitation programmes; and
- vi. To do any and all other lawful things as the Trust may deem fit for the attainment of all or any of its objectives, make rules and bylaws, amend, vary or rescind from time to time.

b. Vision, Mission and Motto:

VISION

To become an institution par excellence, providing comprehensive habilitation measures and pioneering efforts for enriching the lives of challenged individuals.

MISSION

To help every challenged child by

- Reaching medical and therapeutic assistance
- Imparting academic training appropriate to specific needs
- Equipping with appropriate Vocational skills
- Creating necessary social and physical support infrastructure that empowers the child to lead a life of independence and dignity in adulthood.



5. Operations Report

a. Structure of the organization


ACT has both centers based as well as community based programmes which are strictly based on the objectives of the Trust. Started with 7 children affected by Cerebral Palsy, the main rehabilitation centre has now over 284 children (as on 30/04/2020). In December 2007, another centre for comprehensive evaluation of all developmental disorders was started under the name Child Development

Evaluation Intervention and Research Centre (CDEIRC). The first community activity was started in 2003. Now under this head there are 2 projects, a Risk Baby Unit and Home Based Rehabilitation programme. Over all administration of these projects are controlled by Executive Secretary. The main rehabilitation centre has a Principal, Vice Principal, Coordinator and 103 staff members to take care of day to day activities.

b. Human Resources

i. Organization Staff structure

Quality of every organization mainly depends on its human resource. Similarly, staff members are the pillars behind the success of ACT. In order to maintain the quality of service to the beneficiary ACT maintains a high staff student ratio of 3:1. At the main rehabilitation centre the Principal and the Vice Principal supervise all activities and control 103 staff members which include teaching, non-teaching, therapy and voluntary staff. The entire activities are segregated into 10 major units for easy control and for effective rehabilitation. This is based on the type of children, their disability and their functional abilities. In addition, there are technical units and a unit for extracurricular activities. Thus we maintain a student teacher ratio of 3:1. Each class has around 8-10 children and to look after them there is a full time special educator and an assistant. 3-6 such class rooms forms a unit and each unit has a Unit head. So there are 8 units and 28 classes at the main rehabilitation centre. All head teachers report to Vice Principal, who in turn reports to the Principal. The principal will report to Secretary and the Secretary to the Trust. In addition, the center has 2 drivers and 9 bus assistants. At Child Development Evaluation Intervention and Research Centre, a Coordinator supervises 5 staff members and their activities. In the community projects, we have a Developmental therapist who solely manages Risk Baby Unit and there are 18 staff members in 5 Home Based Rehabilitation units. They all in turn report to Executive Secretary and then to the Secretary. ACT is very meticulous in selecting our staff giving thrust for their experience and more to their attitude to the society. Even our Ex. President, His Excellency Dr. A.P.J. Abdul Kalam had appreciated this after his personal experience in our Centre when he visited us on 2005.

c. Beneficiary details

i. Types of children

Right from the inception and even now Adarsh has a very clear focus on admitting children with Cerebral Palsy. Later, in addition to Cerebral Palsy, Adarsh started admitting children with Autism, Down syndrome and Multiple Disability too. As of now Adarsh has 284 children at the Main Centre. Disability wise beneficiary details are available below.

The same focus is extended to our Centre at the city namely CDEIRC and CBR. Even though it is coming under CBR at CDEIRC our focus is on the evaluation and learning disorder where majority of children attend to regular school.

iii. Achievements of the year

We are proud that we could send 3 children to normal stream. Here again as in the majority of cases they fall into early intervention unit, thereby reiterating the importance of the early intervention. Adarsh is among a few organizations which appreciate this aspect and had started to address this right from the start. Till date we have been able to send 82 children to main stream.

iv. Success stories

1. Adon Eldhose

Adon joined Adarsh at the age of 1½ years with a complaint of not attaining developmental milestones appropriate to age, except head control and creeping function. He was admitted in Early Intervention Unit of Adarsh and with the help of intensive early developmental therapy, he achieved all the delayed milestones mainly crawling, sitting, standing and few steps of walking. Apart from these motor developments he has achieved good verbal communication skills and good functional skills. He is able to follow normal Montessori education and was found to be an ideal child to attend to a normal school. But we feel even after joining normal stream he may need to continue Physiotherapy to maintain his physical functions.

2. Adith Krishna

Adith Krishna, now 6 years is planning to join in LKG in their native place in Malappuram. He joined Adarsh at the age of 3 years with a complaint

of weakness in one side of his body. On assessment it was found that he is a child with hemiplegia on right side and had associated attention issues and hyperactivity. He was not able to walk independently at the time of admission. He had good communication skills. With the help of intensive developmental therapy his attention issues is reduced and his sitting tolerance is improved. He started using his affected hand and leg. Now when he is able to attend to a normal school, he is taking a few steps independently and we feel that will be improved gradually with the help of regular physiotherapy.

3. Adam Amrin

Adam Amrin from Kothamangalam came to Adarsh with the complaint of hyperactivity and irritability. His sister is also a student of Adarsh. She has Cerebral Palsy. On evaluation it was revealed that he has features of Autism and has no eye contact. With the help of intensive Early Intervention programme especially in the group and Individualized Education Programme his eye contact is improved with sitting tolerance. After 6 months of training, he was advised to join in a play school for 3 days and to spend the rest of the days in Adarsh. Our intention here is to improve his communication and social skills.

6. Major projects/activities of the year.

6.1. Main Rehabilitation Centre

The main rehabilitation centre looks after children afflicted with Cerebral Palsy, Down syndrome, Autism and Multiple Disability. It functions as a full-fledged special school with all facilities under one umbrella. At the time of Pravesanotsavam 2019, there were 276 children on the rolls at the centre. During the reporting period, 44 children took admission and 38 children discontinued their training due to various technical as well as personal reasons. At the end of the end of the academic year, Adarsh has a total 290 children in the Main Centre. To take care of these children Adarsh has a team of 107 trained and experienced staff members at the main centre. That team includes 29 Special Educators, 8 Physiotherapists, 4 Speech therapists and 2 Psychotherapists, 3 Medical doctors, and other non-teaching staff members. All the children were adequately provided with necessary therapy and training programmes, based on the problems and requirements. Parents of around 80% of children accompany their wards during their rehabilitation programme in Adarsh, which is one of the specialties of the centre. Staff members were regularly provided with

hands on training programmes. Opportunities were also given to attend workshops and seminars to upgrade their technical and training expertise. Last year they attended the following seminars and workshops.

- i. Special Curriculum Training organized by Education Department, Govt. of Kerala for all the qualified special educators.
- ii. Staff members especially teachers and Psychologists attended a half day seminar on Finger Print analysis on children with challenges by Ms Jesna in January 2020.

The centre has an initial comprehensive evaluation process followed by prescribed training and therapies on a classroom basis. During the academic year apart from the initial evaluation, each child was assessed twice and parents were called twice for an open discussion based on the evaluation report.

6.1.1. National Institute of Open Schooling (NIOS)

ACT is an accredited centre for Open Basic Education of NIOS since 2005. ACT admits children only with special needs. Children from other special schools register with Adarsh and appear examination conducted by Adarsh in the OBE level. Apart from the OBE(Open Basic Education) programme, Adarsh has facilities for teaching children in the Secondary and Senior Secondary level. During the reporting period 7 children from ACT passed out Senior Secondary level. During the reporting period, 55 children from 8 other schools attended examinations under OBE level. This is in addition to 44 children of Adarsh. Children with mild to moderate level of Mental Retardation, children with Cerebral Palsy, children with Autism can study academic syllabus using NIOS as it has many advantages as far as the challenged children are concerned. Facility of 5 years duration to complete a level, options of selecting interesting subject etc. are some of them. As already mentioned since 2005, Adarsh has been extending this service to the challenged children. This facility is not extended for children exclusively from Adarsh alone but, for any child who need the same.

6.1.2. Vocational Rehabilitation Programmes

It is only 3-4 years that Adarsh started vocational activities for its children. Main reason was that Adarsh has majority of children with Cerebral Palsy and they do not have the physical and functional skills to perform any vocational activity. But gradually children with Multiple Disability increased and ACT started vocational activities for them. Initially we started with school bag

making and later added paper bag making, candle making etc. But due to lack of training and awareness vocational activities were not that successful as we wish, though we continued it for the sake of rehabilitation. But from 2017 we gave more focus on this segment to bring in more professionalism and the result was quiet encouraging.

Chappathi Making Unit

This is one of the income generating vocational units of Adarsh. Thanks to Shri Jayakumar Bhaskaran from USA who donated the machine to support Adarsh, now around 8 children are able to make Chappathi independently with a slight help of a staff member especially on cooking. In 2019-20, production was considerably low due to lack of demand, but still every day we used to make 90-100 chappathees. Last year we made a net profit of Rs.1575. We have a plan to establish a full-fledged Unit, the details of which are noted in the later part of the report.

Cake making Unit

This is an another income generating vocational unit which was started in 2018. With the involvement of 2-3 students, the unit made a net profit of Rs.66,469/-. Finding the potential of this unit, ACT envisaged to set up a full-fledged cake baking unit in 2019-20. Unfortunately, it could not materialize due to various technical issues. But it is confirmed that the unit will start functioning in first or second quarter of 2020-21. The details are noted in the later part of this report.

Candle Making Unit

Like Chappathi and cake making unit, candles do not have that demand in the market as there are more people and organizations involved in candle making. Also churches who are the main clients for candles, do have their own resources for making candles. Hence in 2019-20, there was a considerable decrease in candle production and correspondingly in its income also. We made only a marginal profit of Rs.6,534/- from this Unit.

6.1.3. Sensory Integration Therapy (SIT)

In 2017-18, with the help of HT Parekh Foundation Mumbai (HDFC Ltd) Adarsh had set up a full-fledged Sensory Integration Therapy room. Special thanks to Shri C V Ignatius for being instrumental in getting the support from HDFC. On an average around 120 children are being given regular Sensory Integration Therapy every month. SIT is mainly useful for children with Autism where children show various sensory processing disorders including

visual, auditory, tactile, vestibular, proprioceptive, olfactory disturbances. It also helps children with Cerebral Palsy and Down syndrome. It is one the extremely useful therapy programmes of ACT.

6.1.4. Family Counseling programme

Started in 2017-18, this programme emerged as one of the most useful programmes of the centre. Though it was intended for parents of children, a good number of teachers and assistant teachers also utilized this service. During the reporting period 170 sessions of counseling were conducted. Apart from the counseling programme Ms Vimina Sujith, the Counselor took awareness class on topics like waste management, time management etc. All these programme add value on the general attitude of our staff.

6.1.5. Mini Supermarket

In order to introduce the concept of small business and financial transaction, the concept of "Bubble" a mini super market was introduced. But when its viability was in question, we were forced to close it. But as the concept gave a real shopping experience for our kids this was re-introduced inside the school building. A small change in our concept and change of place and its accessibility made a sea change to this project. It is now running extremely well where we are exposing four of our kids. Thanks to Ms. Manjula who took real interest in this.

6.1.6. Medical and Surgical Assistance

ACT has been extending medical and surgical assistance ever since its inception in 1998. Finding the importance of medical aspect of rehabilitation in challenged children, ACT always meticulously arranged tie ups with medical doctors and hospitals for medical assistance and surgical help. Today ACT has tie ups with Indo American Hospitals for Brain and Spinal Cord for Neurology, Giridhar Hospital for Eye, Aster Medcity for Ortho, Dr Krishnakumar for Dental, Dr Jyothi for General Medicine, Dr Mathews P George for ENT etc. In addition, ACT takes help from Dr Vinod Padmanabhan of Sudheendra Medical Centre and Aster Medcity for Orthopedic Surgery, Dr Raja Sabhapathi of Ganga Hospital Coimbatore for Hand Surgery etc. 2 children underwent hand surgeries last year at Ganga Hospital Coimbatore. Giridhar Eye Clinic screened over 120 children, Dr. Krishnakumar helped 64 children with Dental problems during the FY 2019-20. ACT also has Dr Chalam Das, a Consultant Psychiatrist who visits the centre on every Wednesday. He screened 34 children during the reporting period. ACT also extends financial assistance to around 15-20 poor children for procuring medicines every month. Each child gets maximum Rs. 500 a month for their medical expenses.

6.1.7. Rehabilitation through magic

This programme was launched on 3rd December 2017 by Shri Gopinath Muthukad. Since then, ACT has been giving regular training in magic with the help of Shri SK Thirumulpad and Adv Hari Raj. After 2 years of successful training, 15 students of Adarsh performed their first official stage show at Hotel Abad Plaza on 3rd December 2019 as part of Vicennial Celebration of ACT. Before that these children had a trial stage show at Cochin Shipyard, Layam Koothambalam, Tripunithura during Athachamayam etc. Very happy to note that one of the students from the group has joined Different Arts Centre(DAC) of Shri Gopinath Muthukad, Trivandrum for full time arts training that includes Dance and Magic. ACT is hopeful that he will scale new heights and may probably find a productive vocation by the help of this academy.

6.1.8. Virtual Realty Programme.

It is a software based digital programme where an artificial environment is created to get the student a real life experience through which their mobility and functional skills are enhanced. Started with 4 children 2018, the unit helped over 24 children in the year 2019-20. Along with this, ACT also provides advanced digital technology programmes like Sensamov Cervical Coordination programme, EMG biofeedback programme, Digital Electrical functional stimulation using Xtrainer. These are advanced Physiotherapy equipment. At present around 30 adult children with Cerebral Palsy undergoes this programme. They are showing significant changes in their functional skills with the help of this programmes. ACT expresses special thanks to TCS especially Shri Dinesh Thampi, Shri Robin Tommy and team. ACT places a special note of thanks to Shri Narayanan Kutty, the then President of Rotary Cochin Central for his support in procuring the above mentioned equipment. Rotary Cochin Central like our corporates were always with Adarsh to support our various programme. This year again they are supporting us for our dream project related to Vocational Rehabilitation.

6.2. Child Development Evaluation Intervention and Research Centre (CDEIRC). ACT started CDIERC in December 2007. After 13 years of existence, now CDEIRC has a stand in the community especially as a one stop centre for providing remedial education for children with Learning Disorders. Apart from remedial education programmes for children with Learning Disorders,

CDIERC also extends basic therapy programmes like Physiotherapy, Speech therapy and Psychotherapy etc. In 2019-20, CDIERC helped on an average of about 46 children per month in remedial education programme and evaluated 53children per month with different developmental issues. There are 6 regular staff members and 2 consultants at the centre.

6.3. Risk Baby Unit

Risk Baby Unit is a mobile hospital oriented new born baby disability screening unit which functions in 4 hospitals in town namely Lakshmi Hospital, EMC, Lissie and CIMAR Hospital. This is probably one of the most noval programme we introduced, after realising the importance of early intervention. At the beginning of last year, there was PVS hospital in the list but the contract was cancelled when the hospital stopped functioning. The unit is managed by a Developmental Therapist who is trained and specialized in dealing with small babies who are born with risks like Low Birth Weight, Prematurity, etc. The unit is working under close supervision of a Neanatologist of respective hospital. Each new born baby, born with risk, is thoroughly screened and assessed with the help of scientific evaluation tools to identify potential delay or deviation from normal development and if something unusual is noticed, we intervene immediately and the baby is given regular stimulation and therapies right from the beginning until a change is observed. In 2019-20, the unit screened 399 babies from 4 hospitals and among them 16 babies had delay in developments. So far the unit screened around 7400 babies since its inception in August 2005.

6.4. Home Based Rehabilitation Programme (HBR)

As always Act says this is the most innovative programme, which was started in 2010 with the help of Bharat Petroleum Corporation Ltd. Started with only 1 unit, today Trust has 5 units. Each Home Based Rehabilitation Unit, consist of a Physiotherapist, a Special Educator and an Assistant Teacher. The team goes to selected child's home and provide them with necessary therapy and training. The selected children generally are from financially poor background and they are otherwise not in a position to bring their child to any special centre like Adarsh due to technical, financial as well as logistic problems. An exclusive vehicle is deployed for this service for each unit. All the five units are supported by BPCL. These 5 units helped 160 children last year covering 15 Panchayats and Municipalities of Ernakulam District. The Trust puts on record our sincere thanks to BPCL-KR for their support for this programme which is continuing since its beginning.

7. School activities in 2019-20

a. Important days and their observations.

- 1. Pravesanotsavam 2019 was held on 6th June 2019. The function was inaugurated by Shri P S Raman, Managing Director of Central Marketing Syndicate. On the day the Trust welcomed 14 new children who took admission. At the function, Shri Jayasankar, Founder Urjja, Shri B Vinod, Manager, Federal Bank, Tripunithura Branch, Chairman of ACT Shri K P Padmakumar, Secretary Shri P R Mahadevan etc. were also participated.
- 2. World Environmental Day was observed on 5th June 2019 with a pledge to make the premises of ACT a plastic free environment. We still follow it.
- 3. Adarsh observed Vayanadinam on 19th June 2019. Part of that vayanavaram was celebrated for a week with quiz, coloring, reading competitions for the children

- 5. Independence Day was celebrated on 15thAugust 2019. Shri P R Mahadevan, Secretary of ACT hoisted National Flag on the day in the presence of some children and staff members who stay near to Adarsh. Sweets were distributed to all.
- 6. Teacher's day was observed on 5th June 2019.
- 7. Sevanavaram was observed by cleaning the premises of ACT by the children, staff and parents.
- 8. World Cerebral Palsy Day was observed on 8th October 2019. Shri Pramod P Thevannoor, Director of SCMS inaugurated the function. Shri P N Narayanan, Senior Trustee and Governing Council Member, Shri P R Mahadevan, Secretary, Adarsh Charitable Trust, Shri Ignatius, Treasurer were also present at the function. A food court was organized as part of the celebration which was inaugurated by Dr Jyothi, a well-known Physician in Tripunithura.
- 9. Children's day was celebrated on 14th November 2019 with befitting programmes by the children. It was a week long programme organized as part of the celebration. Selected children from Adarsh participated at the Children's day function organized by Centre for Empowerment and Enrichment of differently abled children at Fine Arts Hall Ernakulam. At the function Shri Aswin Kumar, Principal of ACT was honored for his selfless service in the field of rehabilitation. Part of Children's day celebration, PTA of ACT organized a medical camp for staff and parents. Different

- competitions also were held for the children including painting, drawing, memory test etc
- 10. World Disability Day on 3rd December 2019 was celebrated as the 20th year celebration (Vicennial Celebrations) of ACT at Abad Plaza. More details on the programme are available in the paragraph about Vicennial Celebrations of ACT. As a part of World Disability Day celebration, BPCL organized an exhibition cum sale of vocational products of selected schools from Ernakulam district, including Adarsh.
- 11. Annual Day celebration of ACT was organized on 20th December 2019 along with Christmas Celebration. The day was filled with dance and songs by children parents and staff members.
- 12. PTA day was celebrated on 28th February 2020 with colourful cultural programmes by parents and teachers. The function was inaugurated by Shri. Murali Madhavan, Executive Director BPCL. Also present were Shri John Joshi District Social Justice Officer who inaugurated the Athijeevanam Project (A vocational project for children above 1 8 years) and Shri Ranjin Raj, Music Director of the film "Joseph" who was the chief guest of the day.
- 13. Due to Covid -19, we could not Celebrate International day of Down syndrome on March 21st, 2020 and World Autism Day on 2nd April 2020. But we did celebrate this through online platform.

b. Festivals and celebrations

- 1. Ramadan was celebrated with various cultural programmes and activities by the children of Adarsh. A sumptuous food was sponsored for the children by family of student Mohammed Safwan from Vocation unit.
- 2. Onam 2019 was celebrated on 6th September 2019. Chief guest of the day was Shri Manoj Das, Chief Editor of Times of India, Kochi. Shri Ignatius CV, Shri K P Padmakumar, Shri P R Mahadevan etc. were also there at the event. The day was filled with song and dances of children, staff and parents.
- 3. Christmas was celebrated on 20th December 2019. The function was inaugurated by Shri Jolly Joseph, a person affected with Paraplegia and Co-Director of Takshan, an initiative to support person affected Paraplegia. Also present Rev Fr. Samson from Felican Centre who delivered Christmas Message to all the children and parents. On the day Shri Sheriff A H, father of Sajid A S a student from Autism Department was honored for his philanthropic gesture for helping us constructing a play area for the children of Adarsh. He sponsored the entire cost of the tress work as well as of the floor tiling. We thank Shri. Sheriff for his magnanimous gesture.

c. Enjoyment and Entertainment

- 1. Children were taken to Central theatre for watching the movie "Android Kunjappan". Almost all the children from the centre watched the movie. Shri Suraj Venjaramood and the producer of the film were also present at the theatre to support the children.
- 2. Part of the promotion work of Malayalam big budget movie Mamankam, a team from the movie, mainly the heroine Ms Prachi Tehlan and Production controller visited Adarsh and spent half a day with the children. Children really enjoyed the day.
- 3. Entire school, children, parents and their staff went to Farm Sanctuary near Kureekkad for a one day Picnic.
- 4. Staff members from 5 Home Based Rehabilitation units and selected students from each unit went for a one day picnic to Wagamon

d. Events and Competitions

b. Athijeevanam – A skill oriented vocational training unit of ACT

In the year 2019-20, with the support of Social Justice Department, Govt. of Kerala, ACT got the sanction to run a vocational skill oriented training unit to train 50 children above the age of 18 years. It is going on well.

c. Hand Surgery

2 children from Adarsh underwent specialized hand surgeries at Ganga Hospital, Coimbatore by Dr Raja Sabhapathy, a well-known Plastic Surgeon. A team from Ganga Hospital had visited Adarsh and shortlisted children who can be benefitted with the surgery. Subsequently ACT selected 2 children who are financially very poor. ACT also identified 2 donors for sponsoring the surgery expenses at the hospital. Both the children, one from the main rehabilitation Centre, Mstr. Jibin Binu and another from Home Based Rehabilitation programme Kum. Sruthi Reji achieved good result after the surgery. Both of them have started using their hand function well. Earlier it was not possible. ACT places on record its sincere gratitude to Shri. V Karunakaran and Shri P R Mahadevan for the financial support which helped the children to undergo surgery.

d. The Breakfast Revolution – A project to reduce malnutrition among the children of Adarsh

The project was officially approved in the year 2018-19. Due to various technical issues it got delayed for implementation. But finally in August 2019, the project was officially launched for the children in Adarsh. Based on the average attendance of the centre, the project is initiated for 200 children in which 70 children are below the age of 6 years and rest above 6 years. These children are given nutritious food supplements in the form of High protein, Bajra, Soya Masala, Khatta Meeta Kurmure, Namkeen etc to reduce the malnutrition among them. This will help to improve their immunity power against common cold, cough and fever. Also it helps

them to undergo vigorous therapy programmes which are required for their problems. The feedback from the children as well as from their parents are excellent. It will take a minimum of 6 months to 1 year to get a valid feedback on the health wise improvement in children. As mentioned children really enjoy the snack every day. All products are of good quality, tasty and healthy. Most of our kids find these products tasty to munch. We hope these power packed snacks will help to bridge the nutrition gap in our children leading to improve physical strength. As per our dietician's report, children below 5 years are getting more benefit with this programme than children above 5 years. We place on record our sincere thanks to Dr Pankaj Jethwani, CEO of Decimal Foundation and Shri N Krishnan through him decimal foundation was introduced to Adarsh. ACT also extends its sincere thanks to Shri. P. N. Narayanan for whole heartedly supporting this entire project.

7.3. Projects for 2019-20

a. New Vocational Training Centre

Adarsh is always blessed that we find abundant help coming to us at the We have been pondering our heads to most appropriate time. accommodate new children as our main Centre was packed with children and activities. Even after engaging special cabin of Chairman and Secretary, lack of space was an impediment to even think of new project. The most worrying part in that was the presence of more than 130 children above the age of 18 who could be only put through some vocational programme. Situation being so, we are so fortunate that Shri. Mathews (Parent of a child from Adarsh) suddenly on a day surprised all of us by donating two floors of a newly constructed Shopping Complex right at the highway with a big swimming pool and some land for agricultural development. We are planning a very big project exclusively for adult kids in the New Centre. There will be a big Chappathi Making Unit, Cake Baking Unit, Vocational Computer Lab., Agri. based Rehabilitation supported by Kerala Agricultural University and Dr. Bala (who is an expert in this), Sensory Swimming Pool, Paper Plate Unit, etc. Even after this, we understand that there will be around 30-40 kids who could not be put in any of the vocation due to their severity of problems. For them we are going to have a Day Care Centre joining with Udayamperoor Panchayat. We are going to have one show room in the Complex to show case and sell our products. Our sincere thanks to Shri. Mathews whose kind gesture surpass all our expectations. Only

because of this, we are now able to plan a very big project for adults. We place on record our sincere thanks. God bless his family.

b. Project with Rotary Cochin Central and ACT to support procuring machineries for the new vocational centre.

It's a 50 Lakhs worth project.

- 1. Semi Cooked Chappathi.
- 2. Cake baking.
- 3. Sanitary Napkin making.
- 4. Paper Plate making.
- 5. ICT based training unit computers for the unit

Official agreement is made and now we are waiting for the approval to procure machineries. On this occasion special thanks is extended to Shri Roopesh Rajagopal, President of Rotary Cochin Central for taking all the efforts to implement for the project. Also special mention to Shri V. Sathyanarayanan, Vice Chairman of ACT and also a member of the club for the support to get the project sanctioned. We hope to start the activities at our new Centre once the situation becomes normal.

c. Digital Class Rooms.

In the last year, we have tried to digitalize our class rooms with the help of Interactive Boards in three classes. This was a major success as the Interactive Boards were operated just by touch. This enabled even the least mobile child to use this. On this note we have given a proposal to Kochi Shipyard to digitalize 10 of our class rooms in the Main Centre. This was gladly accepted by them and we are going to utilize their support to digitalize 7 rooms in Main Centre and 3 in the Vocational New Unit. ACT places on record its sincere thanks to Kochi Shipyard who were always there to support Adarsh right from its inception. We thank Shri. Ramesh, General Manager, Shipyard and Shri. Sampath, Dy. General Manager, Shipyard for taking the initiative. Shri. Varghese, their ex. General Manager and who is one of GC Members also was a guiding force for this. ACT appreciate and sincerely thank Shri. Varghese for his support.

d. Risk Baby Unit and Early Intervention Unit – Revamping


Early Identification and Early Intervention are the integral part of rehabilitation of challenged children. ACT has provisions for both. Early identification is possible through the Risk Baby Unit, where new born babies who are born with any risk are screened at the earliest to identify potential deviation from the normal. At the Early Intervention unit is where intensive


and comprehensive rehabilitation of children with all kinds of developmental disorders is done. For the last several years ACT has not done anything to enhance or strengthen both these activities. In order to create awareness about early identification and early intervention, ACT plans to do some active work especially from the grass root level through Anganawaadi and Kudumbasree health workers.

8. Financial Report

a. Basic Financial Analysis

Audited Financial reports are already distributed to all the members. The details will be shared by our Treasurer. In the following line I am just touching some salient features. This year there is a surplus of an amount of Rs.11.74 Lakhs. Compared to the deficit of Rs.55.36 Lakhs in the previous year. Department wise income and expenditure details are available in the report. The main reason for the annual surplus is the receipt of additional Govt. grant of Rs.17.58 Lakhs towards special package fund, reduction in the deficit on account of transport of children to Adarsh by about Rs 5.5 lacs and an increase in donations. In this context ACT acknowledges with special and sincere thanks HDFC Ltd for their contribution of Rs.35 Lakhs towards revenue expenditure. But as on 31st March 2020, there is a loan of Rs. 44.38 Lakhs which was taken against the Term Deposits.

Salary and allowances is as usual the major financial implication for the Trust. Apart from the main rehabilitation centre all other projects are self-sustained. FY 2020-21 will be more challenging due to Covid-19 pandemic. Trust expects significant decrease in the income especially from the rehabilitation charge levied from the beneficiaries and also from contributions from individuals as well as organizations.

c. Major Future Projects for 2020-21

- 1. Separate vocational unit for children above 18 years. The unit will have a full-fledged cake making unit, semi cooked chappathi making unit, sanitary napkin making unit and Paper plate making unit etc. The Trust intends to run this institute as self-sustainable. In addition, a horticulture therapy unit and some certified vocational courses under NIOS; is also planned.
- 2. Special focus on early intervention unit and Risk Baby Unit involving more hospitals and creating more awareness on early intervention from the grass root level
- 3. Part of making Adarsh main rehabilitation centre as a centre of excellence, special attention to enhance over all activities of the centre.
- d. Accounts of the organization are constructed on Accrual Basis.

10. As you all know our School usually close for summer vacation by the end of April. Even during the vacation period we used to have special therapy sessions for those kids for whom this cannot be stopped. But, due to the threat of Covid-19 we are forced to close the school on 7th of May, 2020 as per Govt.'s. directions. But, we knew that this will affect our kids if the situation prolongs for more duration. Hence, we were searching for alternative platforms to impart whatever is possible and within our limitations. Fortunately for us Tata Consultancy Services and Punerjeeva Technologies extended their helping hand to promote an online platform for our children. We appreciate with sincere thanks the efforts taken by Shri. Dinesh Thampi, Vice President and head of TCS; Kerala and one of our Governing Council members, Mr. Robin and Mrs. Lakshmi of TCS and the entire team of Punerjeeva Technologies for their efforts. Initially during April, it was extended as a Vocational Information Activity and was extended for about 19 sessions till May first week. This was to inculcate an interest among the parents and children on this new platform. This also helped them to get acquainted to the new platform. Ultimately they started enjoying many session as we could bring in many celebrities and eminent personality like Dr. Muhammed Asheel, Shri. Gopinath Muthukad, Shri. P.H. Kurian, Shri. G.S. Pradeep, Shri. Jude Antony Joseph, Shri. John, Dr. Mary Anitha, Dr. Krishnan, Dr. Jyothy etc. Once our efforts became successful we extended our regular classes through online platform from June onwards on a regular basis. This still continues. Now we are able to give upto 60 sessions per week to our children. It is really heartening to note that almost 80% of our kids and all of our staff could adopt and adapt to the new situation very quickly. One of the main reason for this is the acquaintance mothers had with their wards on the daily routine activities happening in our school on all days as we encourage them to be with them on all days. About 80% of our mothers comes daily with their child to our school. This is an edge we have in imparting training through on line mode, as they are very conversant with all our programme including therapy and understand the language of our professionals and what is expected of them to do. But, we realise that there is still some children, who due to their physical problems could not receive any benefit by the present system. For them we have planned some alternative and this will be implemented as the circumstances gets comfortable and congenial for the same. I take this opportunity to specially put on record the absolute support which I

received from our Chairman Shri. Padmakumar sir. His timely advise and strong support gave all of us the kind of confidence that nobody could have failed even if he wish to. Our Vice Chairman Shri. Sathyanarayanan and Treasurer Shri. Ignatius were also always there with us throughout this tiring period. Thank you all.

11. Conclusion

Friends, as you all know we are passing through a very tiring period. Probably even in our wildest dream none of us has ever thought of a situation like this. But even at this tiring time, we at Adarsh are fully vigilant and are working round the clock to see that all our kids are safe and are keeping good health and are in good spirit. Adequate arrangements are being made to contact them individually through our network of teachers to enquire on their welfare and requirements. We are fortunate that timely help reached us from various corners like the one from Give India, TCS, Punarjeeva etc. so that we could extend it to all our children. While we thank all of them, we are confident that we will come through this crisis also and will certainly be blessed with lot of support from our strong circle of individual friends and corporates which we need in abundance in the coming months.

Friends, you all know we have celebrated our Vicennial year in the most befitting manner during the reporting year. It was a very colourful event where all our nostalgic moments were rekindled. The most important and colourful part of the event was the release of book "Resolutely towards an Adarsh" written by our Chairman Emeritus Shri. K. Neelakantan sir. I personally know the pain he has taken in bringing this book which depicts a true history of Adarsh. I salute Shri. Neelakantan sir whom I consider as my mender and guide for his attempt to bring out such a book which as far as my knowledge goes is the first of that kind. From the bottom of my heart, I thank the most respected Shri. Neelakantan sir, for all the pain and effort that he has taken for this.

Friends, as always reported in my previous reports whatever Adarsh could achieve is because of the efforts of our committed and dedicated members of staff. I was watching with bewilderment how easily and quickly they adapted themselves into digital mode in extending their services to our kids. This is something incomparable which we are witnessing in Adarsh for the last 22 years. I thank each one of them for their dedicated and sincere services. Ashwin with us, whose dedication, sincerity and leadership quality is something which cannot be compared or compromised. Smt. Bincy our Vice Principal also need special appreciation.
